

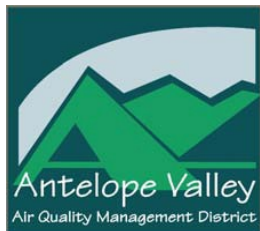

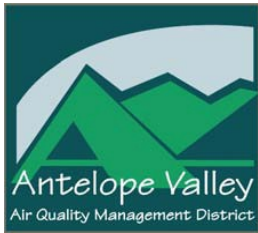

If the point-of-contact changes the sign must be updated with the new contact information within 30 days.</p>
